A. Health Insurance Update

Scott Robinson reported that he has spoken to several people who expressed the opinion that there will be some major changes coming due to the Affordable Care Act.

To have a group plan there must be 50 participants. In any group over 50, each membermust do a minimum of 30 hours of service. There is an audit every month and if there is a violation, there is a penalty. Working 30 hours encroaches on FLSA guidelines.

Scott spoke with Tina Wyatt with Moss Financial. She suggested that individuals needing insurance sign up with the Affordable Care Act and volunteered to walk each member through the sign up process. She will speak at next month's meeting.

Scott stated that perhaps they could approach the district for a contribution.
