### Pg. 4, sect F – Policies

- 1. Cadets must remain in high school...will be suspended from all Cadet activities until the next high school progress report shows a passing grade.

  - a. As Chief, I do not want anyone under the age of 18 responding to calls.

- 9. Under no circumstances should a Cadet drive any Estero Fire Rescue apparatus or vehicle.

  - a. Why are they riding on the apparatus?
- 11. No Cadet shall be in a fire station without a minimum of 2 firefighters present or without one of the Cadet's parents.
  - a. Why are the firefighters listed? They are not going to be responsible for or interacting with the Cadets unless they choose to; in which case they need to formally request to be a part of the Cadet supervisory staff. They will also probably require appropriate training to be supervisory staff for the Cadets.

- 23. Cadets must leave the fire station by 2100 hours on school nights and 2200 hours on non-school nights, unless prior approval has been obtained from an Advisor.
  - a. A minimum of two authorized supervisory adults / Advisors must be with the Cadets at all times when they are in the fire station.
- 24. PASS tags will be utilized at all incidents and training exercises with Key Largo Fire personnel.
  - a. As Chief, I do not want anyone under the age of 18 responding to calls.
- 25. Cadets will be seated in vehicles...
- 26. At no time will a Cadet take the place of an on-duty firefighter.

# Drug Testing Release

Third sentence change "safework" to "safe work".

- 3. The testing will be conducted on Key Largo Fire Rescue property, using a rapid drug screen (urinalysis), and may be administered without advanced notice.
  - a. Who is administering the drug screening and how is it conducted?
  - b. Key Largo is a "Drug Free Workplace" and this allows a positive test result Cadet to be suspended but not terminated.
