***LEVY OF EXCESS MILLAGE, AT VARIED RATES, TO OPERATE TRAUMA STAR***

**Do you favor legislation, for the purpose of operating TraumaStar, a local government owned and operated air ambulance, to levy ad valorem tax not to exceed fifteen cents per \$1,000 taxable value below Mile Marker 95, and not to exceed 7½ cents per \$1,000 taxable value from Mile Marker 95 to Miami-Dade County, in addition to the millage rate allowed by Florida Statute Section 200.185 without voter referendum?**
